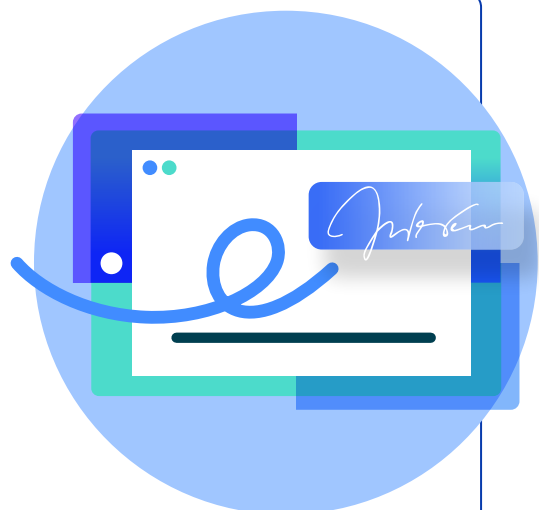

Or, you can initiate a signing process once you have created a candidate profile and updated that profile to a specific stage, such as the Offer stage, which will send the candidate their employment offer.
- Recipients then access the document securely and eSign it.
- Once all required signatures are captured, the document is automatically marked completed.
- The signed documents are automatically stored within the Workday profile of each employee. This automatic document management eliminates the need for manual uploading and ensures that all signed documents are securely stored in Workday.
- Your organization can audit the entire signing process, including who signed the document, when it was signed, and any modifications made.
- This comprehensive audit trail provides transparency and accountability, helping your organization demonstrate compliance during audits or deter legal disputes.
